





In May of 2017, the Ludlow Community Center/Randall Boys & Girls Club received Boys & Girls Clubs of America's (BGCA's) prestigious Marketing & Communications (MAC) Award during the organization's 111th Annual National Conference in Dallas. The Club was selected out of thousands of applicants across the country for implementing the best marketing strategy for advertising. This is the first time the Club has received national recognition for marketing and communication efforts.

Specifically, the Club was recognized for creating the "Open the Door, Take the Tour" marketing campaign. The campaign centered around creating materials that highlighted the youth that we serve on a daily basis, showing the Club's impact on children and families.

SPLASH PARK RENOVATION



In January of 2017, Balise Motor Sales agreed to partner with the Ludlow Community Center/Randall Boys & Girls Club to help renovate the Club's Splash Park. The Splash Park, originally built in 2011, was showing signs of wear. Two of the water elements no longer functioned and the pea stone surrounding the concrete base was proving to be problematic. Kids would complain that the stones were uncomfortable to walk on and loose stones would end up strewn across the park and in the grassy perimeter.

The Club launched a campaign during the month of February to try to raise \$5,000 from the community, with the understanding that Balise Motor Sales would donate \$2 for every \$1 raised, up to \$10,000.

The community rallied behind the cause! Club members, alumni, parents and the general public all stepped up to help us reach our goal. Even the children pitched in and donated coins to help "get rid of the rocks!" We raised over \$21,000 for the project in just 28 days.

In addition to financial support, the Club received an incredible amount of in-kind support for the project. Special thanks to Baltazar Contractors, Inc. and Meredith-Springfield Associates, Inc. for donating their time and expertise in the renovation.

On June 15, the Club hosted a Grand Reopening Ceremony for the new, rock-free Splash Park. In attendance were project donors, board members, Amy Roberts, Director of Human



Resources from Balise Motor Sales, State Representative Thomas Petrolati, Selectman Derek DeBarge, and – of course – the kids. Watching and listening to the children run around the renovated Splash Park was the perfect reminder of why this project is so important to the Club and to our community. Thank you to everyone who helped make it possible.

2016 TREASURER'S REPORT



It is my pleasure to present the 2016 Treasurer's Report for the Ludlow Community Center/Randall Boys & Girls Club. I am proud to be part of such a great organization in our Town that offers exceptional resources for youth, adults and seniors.

Our independent auditor, Downey, Sweeney, Fitzgerald CO., P.C., had concluded, for the year ending December 31, 2016, that the financial statements were in accordance with the governing bodies. If you are interested in getting a closer look at the audited financial statements or Form 990 and Form PC please contact myself or the Club's president to schedule an appointment.

Total assets have remained relatively consistant from 2015 to 2016, while liabilities have decreased by approximately \$20,000. The change in net assets (surplus) for the year was \$22,278. This surplus allows us to pay down our liabilities and reinvest in our staff and programs.

Total support and revenue of the Club was down approximately \$50,000 in 2016. For the year, program revenue increased by \$58,000 while community support and fundraising were down \$108,000 due to a one time bequest that was received in 2015. While membership dues declined \$12,000 childcare program fees increased \$56,000. Our programs continue to have good enrollment and we do our best to provide low cost quality programs. We encourage new memberships so that we can share our Club with more and more families in the community.

Each year we work from a balanced budget while we challenge our staff and board to think of creative ways to increase our services. Your continued support allows us to offer new and improved programs and services while maintaining low cost child and adult programs. We are always open to the ideas of our community and welcome and suggestions and comments.

The following pages are excerpts from our 2016 Audit and include the Independent Auditor's report, Statement of Financial Position and Statement of Activities and Changes in Net Assets.




